



Voluntary National Survey on the Implementation of the Madrid International Plan of Action on Ageing (MIPAA) in Asia and the Pacific (to inform the Asia-Pacific Fifth Review and Appraisal of MIPAA)

Background

This voluntary national survey will inform the Asia-Pacific Fifth Review and Appraisal of the Madrid International Plan of Action on Ageing (MIPAA)¹ to be organized by ESCAP in 2027.

MIPAA is the global guiding document on population ageing adopted at the Second World Assembly on Ageing, in 2002. It calls for regular and systematic reviews of MIPAA implementation by Member States. After four successful reviews at national, regional and global levels, the Economic and Social Council, through resolution 2025/8, endorsed the timeline for carrying out the fifth review and appraisal of MIPAA, as outlined in the report of the Secretary-General (E/CN.5/2025/5). The report identifies 2026 as the year to conduct national reviews and appraisals, 2027 as the year to conduct regional reviews and appraisals and 2028 as the year to conduct the global review and appraisal at the sixty-sixth session of the Commission for Social Development. The ECOSOC resolution notes that 2027 also marks the twenty-fifth anniversary of the Second World Assembly on Ageing and invites United Nations Member States to identify actions they have taken since the fourth review and appraisal exercise and to present them to the regional commissions during the regional reviews and appraisals in 2027.

Pursuant to ECOSOC resolution 2025/8, regional commissions were asked to continue to facilitate the review and appraisal at regional levels by: (a) providing assistance to Member States, upon request, in organizing national review and appraisal exercises; (b) organizing regional review meetings, taking into consideration that these meetings will coincide with the twenty-fifth anniversary of the Second World Assembly on Ageing in 2027; (c) assisting Member States, upon request, in following up on analysis resulting from the regional reviews; (d) using an inclusive and coordinated approach in relation to the participation of civil society in the planning and evaluation processes of the review and appraisal exercises; (e) promoting networking and the sharing of information and experiences; (f) providing an analysis of the main findings, identifying key priority action areas and good practices and suggesting policy responses by 2027; and (g) assisting and providing advice to Governments, upon their request, within existing resources, in the gathering, synthesis and analysis of information, as well as in the presentation of the findings of national reviews and appraisals.

Where possible, synergies and complementarities with the WHO Mid-term Evaluation of the United Nations Decade of Healthy Ageing (2021-2030) have been considered, to ensure coherence and reduce reporting burdens on Member States.

The Asia-Pacific voluntary national survey on MIPAA implementation is an important and integral part of the Asia-Pacific Regional Review and Appraisal process of MIPAA in 2026-2027. The process consists of: (a) voluntary national surveys; (b) stakeholder consultations; (c) documentation; and (d) the intergovernmental meeting. Suggestions for completing the voluntary national survey on the implementation of MIPAA in Asia and the Pacific

The survey should be completed by ESCAP member States, through their national focal points on ageing,² in consultation with ministries and departments involved in addressing population ageing at national levels.

The survey is structured according to the MIPAA priority directions, issues and objectives.³ Some objectives have been merged to facilitate reporting.

The following guidelines are intended to assist member States in reporting on MIPAA implementation:

1. Given the multidimensional and cross-cutting nature of population ageing, it is suggested that ESCAP member States set up (or strengthen) a coordination body or mechanism to, inter alia, coordinate their responses to the survey (E/RES/2025/8, OP6). The group should include members from different institutions, such as: Ministry of Health, Ministry of Labour, Ministry of Education, Ministry of Social Development, Ministry of Women and Gender Affairs, Ministry of Planning, Ministry of Finance, National Statistical Office, Human Rights Commission.
2. A bottom-up participatory approach should be followed by inviting, inter alia, civil society, including organizations of older persons, to contribute to survey responses (E/RES/2025/8, OP5 and OP7).
3. Gender perspectives and disability inclusion should be mainstreamed when answering the questions.
4. Member States are encouraged to reflect on any national data collection initiatives for implementing the 2030 Agenda and related SDGs as they relate to MIPAA and report on the respective SDG indicator(s) (relevant SDG indicators are listed along with the questions, when applicable).
5. Answers should focus and report on progress made since the fourth review and appraisal at the regional level in 2022, (E/RES/2025/8, OP5).
6. Answers may combine quantitative and participatory qualitative data and analysis, disaggregated by age, and, when necessary, by other relevant factors, including sex and disability, and, where appropriate, sharing of good practices in such data collection (E/RES/2025/6, OP8).
7. Answers should include the sharing of information and experiences (E/RES/2025/8, OP9e).
8. ESCAP, as the organizers of the Fifth Review and Appraisal of MIPAA in Asia and the Pacific, will provide technical assistance to its member States in completing the survey, if requested, and in coordination with other United Nations entities, if possible.
9. In addition to providing answers to the questions in the survey, member States are invited to complete the self-assessment regarding MIPAA priority directions at the end of each section of the survey. This will help member States to analyse MIPAA implementation in a comprehensive way and identify areas of achievement, remaining challenges and gaps.
 - a. Each thematic area and question should be self-assessed by member States in the following way:

Status	Description
0	No action initiated
1	Action planned (policy/strategy drafted but not implemented)
2	Implementation initiated with limited coverage or scale
3	Implementation in progress at moderate or national level
4	Fully implemented and monitored; evaluated with lessons learned

- b. Member States are encouraged to include specific examples and links to supporting documentation to explain the status of their policy implementation.
10. Ideally, countries should respond to all questions, but it is fully understood that, given the national context, they might not be able to do so.
11. Supporting documentation should be included and should be attached as annexes, if possible.
12. The companion document attached to this survey provides explanations of some key terms.

 - **Q4 2026–Q1 2027:** analysis of survey results and synthesis report prepared by ESCAP
 - **Q2/Q3 2027:** Fifth Asia-Pacific Regional Review and Appraisal of Implementation of MIPAA (ESCAP)
- **2028:** Global review and appraisal at the sixty-sixth session of the Commission for Social Development
